In 2020, with the onset of the COVID-19 pandemic, we began to schedule shorter sessions of Canadian Yearly Meeting and Representative Meeting on Saturday afternoons throughout the year. Documents distributed for these meetings include Reporting and Clearness reports, CYM budgets, and audited financial reports. Now the CYM Clerks request annual reports in May. All reports received by June 30 will be distributed before Yearly Meeting. With CYM's current year-round schedule, the labels "in advance" and "late" are not helpful.

During the winter of 2022 the CYM Clerks prepared compilations for 2020 and 2021 containing the minutes for Representative Meeting and Yearly Meeting sessions (in chronological order) plus all reports received from CYM committees, other CYM bodies, and CYM representatives to other organizations (Friends World Committee for Consultation, Friends General Conference, Canadian Council of Churches, etc.) during the calendar year.

The **Canadian Yearly Meeting Minutes and Reports** for **2020** and **2021** are posted on quaker.ca. A similar compilation is in progress for 2022. This practice will continue.

The files for the annual **CYM Minutes and Reports** are formatted for printing. It is hoped that these documents will replace the bound copies of Yearly Meeting Minutes and Reports circulated until about ten years ago. Copies will be printed for the Canadian Quaker Library and Archives. Monthly Meetings and individual Friends who would like to have paper copies of the annual *CYM Minutes and Reports* for easy consultation are encouraged to print their own or make local arrangements for multiple copies.

CYM Land Acknowledgment

We commit to re-evaluating this acknowledgement regularly. Those using this land acknowledgement are encouraged to personalize it by acknowledging the host community and its people by name."
